

**ELEANOR FLEA MARKET

VENDOR CONTRACT

Upon signing and returning the reservation of space, the vendor acknowledges responsibility to The Eleanor Park Board for any and all damages to the grounds as a direct result of the negligence of the vendor. The Eleanor Park Board is not responsible for theft, loss, damages, or bodily injury to the vendor or employees of the vendor.

By signing the agreement, the vendor accepts and acknowledges all rules and regulations below:

1. The vendor agrees to pay \$10.00 per day, per space for each site measuring approximately 20' x 20' each.
2. The vendor understands that reservation of spaces is on a FIRST COME FIRST SERVED BASIS. Reservation will be guaranteed if payment is enclosed with signed reservation form until all available spaces have been reserved.
3. Vendor setup will begin by 8:30 a.m. on the morning of the flea market. Reservations will be held until 9:30 a.m. Remaining available spaces will be sold to those vendors on the waiting list. Gates will open to the public on Friday and Saturday at 10:00 a.m. and will close at 6:00 p.m. and open Sunday at 12:00 p.m. and close at 6:00 p.m. Vendors are welcome to stay on premise overnight in their own provided camper or tents.
4. Electric and water hook-ups ARE available for most lots. Vendor is responsible for all electrical cords and water lines necessary for hook ups.
5. 14 Lots are available under shelter and 105 lots are available outside.
6. The vendor must supply his/her own canopy and tables for display.
7. The sale of firearms, alcoholic beverage, live ammunition, pornographic materials, palm reading, or any game of chance is STRICTLY PROHIBITED.
8. Vendor is responsible for removal of his/her trash from the premises. No bags or containers are to be left on the premises. Dumpster is located at the Eleanor Pool.
9. NO REFUNDS will be given due to weather condition.
